Terms & Conditions

The terms and conditions set out below ("**Terms and Conditions**") apply to the **bpSA and Capitec Campaign** ("**Promotion**") being run and administered by bp Southern Africa (Proprietary) Limited ("**Promoters**" or "**us**" or "**we**" as the context requires) with its registered address at 199 Oxford Road, Oxford Parks, Dunkeld, 2196.

These Terms and Conditions ("**Terms**") will prevail in the event of any conflict or inconsistency with any other communications sent to entrants by us, including advertising or promotional materials.

Prize redemption instructions are deemed to form part of the Terms and Conditions. These Terms apply to Participants in the Republic of South Africa ("**Territory**").

Eligibility

Privacy

5.
